Sub: Categorization of Colleges --Submission of compliance report of deficiencies/shortcomings/ conditions to consider the matter of Extension/continuation in provisional affiliation for the session 2011-2012.

Sir,

It is to inform you that this University had granted the continuation in provisional affiliation to your college for the existing courses i.e. B.Ed/M.ED/B.LED with existing intake for the session 2009-10 and 2010-11 with this clear stipulation that all the colleges shall make up the deficiencies/shortcomings pointed out by the inspection committee/screening committee as well as the conditions laid down in the continuation letter within a period of three months. Further this period was extended for one month i.e. total 4 months. The above stipulated period of four months has already been expired and most of the colleges have not submitted the compliance report with this University. The compliance report, submitted by some of the Colleges of Education are also incomplete

The Academic Council while considering the matter of categorization of Colleges of Education/Course and letter dated 4.5.2011 of the State Govt. has resolved that all the colleges placed in category 'C' be required to make up the deficiencies within a period of 4 months

In terms of the above decision of the Academic Council of this University, I have been directed to ask you to submit the compliance report/complete compliance report of shortcomings/conditions already conveyed to you alongwith supporting documents and approval of required eligible teaching faculty from the University for further verification within the above stipulated period of 4 months failing

which disciplinary action in terms of Act, Statutes and ordinances of the University already conveyed to you shall be initiated against your college.

Further the colleges/course falls in category 'A' and 'B' are also required to submit the complete compliance report of the shortcomings/conditions already conveyed while granting the continuation in provisional affiliation for the session 2009-10 and 2010-11, alongwith approval of required eligible teaching faculty from the University within the above stipulated period otherwise similar proposed action as against 'C' category college shall also be initiated against their college.

This may be treated as **MOST URGENT/TIME BOUND**.
